HEATING OIL

Subject to the terms of this agreement, BOUCHER & JONES INC. agrees to supply the Applicant's entire requirements of Heating Oil at the Applicant's property for the heating season ending May 31 next, and for subsequent heating seasons thereafter at BOUCHER & JONES INC.'s prevailing tank wagon price at time and place of delivery. This Agreement will automatically continue from year to year but may be terminated by either party at any time by giving 30 days written notice.

BOUCHER & JONES INC. will fill the Applicant's tank from time to time without order so as to maintain an adequate reserve of Heating Oil, provided the Applicant's account is in good standing. However, should the reserve fall to an abnormal low or should there be any alteration in the Applicant's building, storage tank capacity or Heating Oil requirements, the Applicant shall advise BOUCHER & JONES INC. immediately.

BOUCHER & JONES INC. shall not be liable for failure to supply Heating Oil hereunder if prevented by acts of God, fire, labour disturbances, impassable roads, shortages of Heating Oil or any other cause reasonably beyond it's control. BOUCHER & JONES INC. shall not be liable for injury or damage to persons or property resulting from the existence and operation or non operation of the Applicant's oil burner. Further, BOUCHER & JONES INC. shall not be liable for any damages whatsoever resulting from it's failure to supply Heating Oil hereunder while the Applicant's property is vacant nor for any damages whatsoever resulting from BOUCHER & JONES INC.'s failure to perform hereunder, except the cost of restarting the Applicant's furnace and the delivery of 45 litres of Heating Oil without charge.

This document, when signed by the applicant and signed by a duly authorized representative of BOUCHER & JONES INC., constitutes an Agreement for the Applicant's supply of Heating Oil.

COMMERCIAL, FARM OR INDUSTRIAL

In the event of shortages, BOUCHER & JONES INC. reserves the right to allocate supply as it sees fit amongst it's customers. Further, BOUCHER & JONES INC. shall not be liable for any damages whatsoever resulting from our failure for any reason whatsoever to supply petroleum products hereunder.
